DATA RETENTION PERIOD	<p>Data in the PESEL register are retained indefinitely.</p> <p>Your personal data shall be retained by the Mayor of Warsaw for the time necessary to process your matter, i.e. to accomplish the purpose(s) described in the Population Registration Act, and subsequently for the time and to the extent required by the applicable law, and in particular for archiving purposes in the public interest, or research, historical or statistical purposes.</p> <ul style="list-style-type: none"> • population registration – 50 years • residence registration – 10 years • updating population registration data – 5 years • sharing data from, and issuing certificates based on, population registration or issued ID records – 5 years
RIGHTS OF DATA SUBJECTS	<p>You have the right to access your data, and to request that your data, or the data of other persons over whom you have legal custody, such as your children, be rectified</p>
RIGHT TO LODGE A COMPLAINT WITH A SUPERVISORY AUTHORITY	<p>In addition, you have the right to lodge a complaint to the supervisory authority responsible for the protection of personal data in the Member State of your normal residence, work, or any alleged violation.</p>

VOLUNTARY OR REQUIRED DATA PROVISION	<p>You are required to provide your personal data under the Population Registration Act of 24 September 2010</p> <p>If you fail to provide your personal data to comply with your obligation to register your residence, the Mayor of Warsaw will not be able to meet its obligations or exercise its powers, as provided for in applicable law, including to handle your requests for registration or de-registration of your habitual residence, etc.</p> <p>Foreign nationals who are not citizens of any EU Member State, EFTA member state that is party to the European Economic Area agreement, or the Swiss Confederation, who fails to meet their residence registration obligations, is subject to a fine.</p>
